#### President Update - Todd Holden

# **Fundraising Discussion with Parents**

- There is an air-conditioner that's out in the building. Parents have paid for the ACs in the past. The only appliance vendor that's allowed by the DOE has quoted us \$2,500 for a single air-conditioner.
- Multi-Purpose Room Jonathan will donate his time/resources for a party if space can be provided school space is a challenge
- Andrea has talked to OlieLoli, who will donate space for a parent's night-out; parents pointed out that there has not been great turn-out for these events in the past
- Can we create a private Facebook group? We need to ask Ms. Leto weighing the pros and cons. Social media can help communication with so much going on this year perhaps we can do a google chat group or a different medium. DOE is serious about privacy especially on Facebook they look at staff Facebook pages and track what they are doing.

- A lot of changes this year, but it is for the benefit of our students we need to stay positive and work with Ms.
- No Playground could we do black rubber padding outside? They are very expensive, as anything like this
  requires DOE contractors.
- School photos and harvest festival will be the first anticipated events.

### **Update Ilyse Sisolak**

- Solution to playground issue Ms. Leto is willing to have parent volunteers and have them organize things outside – she doesn't have the staff to do this. Right now Ms. Maria and Ms. Davina go outside.
  - A sign-up genius can be created for sign-up. It would be only 10-15 minutes long it wouldn't be a big commitment.
  - Recess Coordinator Volunteer Vanessa Castor-Jacob
- Construction is in full swing. The playground has been eliminated. Two years from now, Sept 2019, the new building will be finished for new kids. After that they will do some construction on the existing spaces – cafeteria will be converted to pre-k classrooms
  - o In 2019 they will not grow all the classes at once
  - Playground will be for the young grades in the future. SLT is discussing the long term plans for the outside play after construction is done.
- 3rd graders continuing in the school the now 3rd graders were supposed to be able to continue on, Ilyse has been working to find a solution. A trailer or pre-k class elimination were the options 3rd graders are 36 kids in total right now a combined classroom will be able to be 32 kids. One Pre-K class will be kept to allow for siblings.
  - A letter/petition signed by parents was sent out at the end of the school year to Andrew Hevesi and Melinda Katz's office and the School Construction Authority. Ilyse will be attending a meeting at the beginning of October to plead our case. If parents need to attend, she will let us know.
