#### **SLT Update - Michelle Molfatta**

- On the educational impact statement that went to parents for expansion to 4<sup>th</sup> and 5<sup>th</sup> grade includes a zoning priority for 196. It includes how pre-k and kindergarten would get priority.
  - o Priority 1: Students zoned to 196 who have siblings
  - Priority 2: Students zoned to 196
- The letter states that there is no end to this zoning, effectively making PS 303 a zoned school.
- We have to approve the expansion plan. Our goal will be that they revise the proposal before the vote. We will have 4 kindergarten classes in 2019. We can accommodate our own siblings and PS 196 waitlisted kids. Our position is that we would like to help 196 but we need to do that without harming our own children. We would like the parents to send emails to the DOE and explain how it will affect us. The message has to positive, but we want fairness. Kids can be harmed by being forces to change school from pre-k to k. June 5th Meeting is the public hearing in the school.
